	Meeting was called to order at 6:34pm.

	Pastor Kuenzel led devotions and prayer.

	2022 Commentary:		
	 2022 faith sharing came in at \$517,228, which was in line with last year. 		
	 Other income (rent, reimbursements, etc) is estimated at \$20,000 		
	 We received a portion of the employee retention credit on 12/30/22 (\$18,141). 		
	We plan to use \$13,000 of this payment to make up the \$13,000 deficit in 2022,		
	pay \$4,000 for the preparation of the Employee Retention Credit. That leaves		
	another \$1,300 that can be applied to 2023.		
	2023 Discussion:		
	- Pledges for 2023 are up by \$19,000 vs 2022.		
	- 3% staff increase is what is recommended by the Synod.		
	- Estimated of \$57,000 worth of Employee Retention Credit anticipated to be		
	paid to the church in 2023.		
	- Youth and Family Ministry discussion on increase position from 20 hours		
	(hourly) to 30 hours (salaried) per week, with the vision to have that position at 40 hours per week in 2024.		
	- As our annual expenses increase, consider having the full three months' worth		
	of expenses in our emergency fund, which equates to an additional \$20,000 vs		
	what is currently in our emergency fund.		
	- Building condition is good, including water filtration, furnace, steeple, etc, so		
	not expecting any large building expenses.		
	2023 Budget Next Steps:		
	- Debbie, Steven and Pastor will pull together a couple different scenarios on the		
	2023 budget so that all the numbers can be vetted and finalized prior to the		
	council meeting in two weeks.		
	- Next meeting there will need to be a motion to increase Pastor's vacation time		
	from four to five weeks instead of participating in the annual 3% salary		
	increase.
