REPORT FROM CHURCH COUNCIL



We are truly grateful for the many accomplishments here at Light of Christ over the past year, especially as we navigated a time of transition. Your faith, resilience, and dedication have been a testament to God's work in our midst, and together, we've continued to grow stronger as a community.

Our **worship** participation continues to grow, both in-person and on-line.

Our **music ministry** continues to grow. One of the highlights of the year was the Lessons and Carols service in December.

We welcomed **30 new members** into our community of faith this year, with new visitors worshiping with us on many Sundays.

We navigated a **season of transition** after Pastor Bruce's retirement, partnering with two bridge pastors and several guest pastors.

We are excited to welcome **Pastor Tim Wheatley** to Light of Christ starting in January 2025. A special thanks goes to our **Call Committee** (Cheri Ashfeld, Mike Boyack, Billie Chock, Rhonda Current, Sophia Grant, Paul Ludwig, Erin Olson, Pat Czock, and Natasha Werner as alternates) for their dedication and patience throughout the process.

We had **2 summer youth trips**: 21 high school students and 6 adults went to Chicago on the mission trip, and 6 youth and 3 adults headed to the Boundary Waters Canoe Area. It was a blessing to have these opportunities, and these trips continue to serve as a catalyst for growth for our youth and family ministry.



Our children, youth, and family ministry is thriving. On Wednesdays, we have about 80 children participating in our weekly Explorers, Voyagers, and Pathfinders program; and 65 seventh, eighth and ninth graders participating in our confirmation ministry. We had 6 new families join in 2024/2025.

We pledged \$194,000 to our **Capital Campaign**, enabling us to fund important repairs and updates, including work on the steeple, building security, new live stream cameras, and improvements to the parking lot.

In addition to all of this, there are many things that go unnoticed but are vital to our shared life. We want to express our heartfelt gratitude to each of you in this congregation. **Thank you** for your generosity, prayers, and the countless ways you serve and support one another. Your commitment to this church and God's work is a true reflection of your faith, and we are deeply grateful for all that you do to make this community special.

CHILDREN & FAMILY MINISTRIES (Preschool – Grade 6) ANNUAL REPORT Submitted by the Children & Family Ministry Team



As we reflect on 2024, it's clear this year was filled with growth, connection, and joyous moments within our Children & Family Ministry.

We started the year with a visit from the WAPO camp staff, who gave our Voyagers & Pathfinders a taste of the camp experience, sparking excitement and anticipation for future adventures. Then February into March our young people helped promote, gather, and pack food items for *Pack the Pew* food drive.

On March 17, 13 children received their first communion with an additional 3 waiting till October. April 14 saw us giving Bibles to 14 third graders. In April we also hosted an Earth Day family cleanup service project.

May was full of celebrations and farewells. Mother's Day was a heartwarming event, providing families the opportunity to surprise moms with roses, while supporting our CFM budget and school year registration scholarships. We ended May with an epic

end-of-year celebration, which doubled as an early farewell to Pastor Bruce, filled with skits, songs, and a hand-made quilt created from each child's cherished memory of him. We closed out the school year with an average participation of 81 children across our Explorers, Voyagers, and Pathfinders programs—almost double our numbers since 2022!

Summer included WAPO camp adventures with a total of 19 youth participating. With the support of the Endowment Committee, we purchased and dedicated a new rug for the prayer ground, enhancing our worship space for our youngest members. VBS, our last summer event, was a success with 45 children participating and over 32 youth and adult volunteers contributing their time and talents!

Rally Sunday in September was fun filled with various games and activities. Eight children began their Bible exploration by receiving a Story Bible. They also began their Global Barnyard initiative raising \$1,102 by end of October.



In November we were excited to host "Friends for a Cause," supporting families in our community, led by Ashlyn Wortz. We also looked forward to our annual Christmas program in December.

We are deeply grateful for the support of our congregation, volunteers, and families. Your dedication and generosity have allowed us to create a nurturing environment where our children can grow in faith and community!

YOUTH & FAMILY MINISTRIES (Grades 7-12 & college-age) ANNUAL REPORT

Youth & Family Ministry (YFM) Team Members: Lesley Berscheid, Ken Chock, Katie Horeis, Kirsten Kelly (staff), Adam & Rachel Kopperud, Justin Lindall, Vicki Noetzelman, Jennifer Slipka, and Natasha Werner (Council rep).

I am so grateful to have transitioned to full-time this year so that we can continue to look to the future and grow the YFM at Light of Christ! Thank you for your trust and partnership in this impactful and life-changing ministry. It has been a year of transition as we said goodbye to Pastor Bruce Kuenzel and waited to see what the future held. We are excited to have Pastor Tim Wheatley join us in January and be "full-strength" again as a staff! Here is a brief look into the YFM that took place in 2024:

- **NEW:** Started planning for our first ever 7th and 8th grade mission trip that'll take place June 2025!
- **NEW**: Switched to quarterly YFM Team meetings. We are so grateful for these dedicated volunteers that give their time to vision, plan, and implement the youth ministries each year!
- **NEW**: Worked with Jennifer Slipka to organize a BWCA trip for juniors and seniors. 6 youth and 3 adults attended (Ken Chock, Jennifer, & Ryan Tool) and plans are underway for a 2025 trip!
- NEW: Brought Trunk or Treat back (see photo)! A great fellowship/outreach event for all ages and a laid-back way for people to check out our church.
- **NEW**: Coordinated with the Healing and Wholeness Team to host the *Walk a Mile* event in conjunction with Confirmation (and all Wednesday afternoon kid's programs) on 10/2/24. We had over 100 people attend and stay for pizza afterwards! This event creates community and raises awareness for mental health.
- NEW: Worked with Katie Kohler to lead our first intentional Youth Worship on 8/25/24. Our goal for 2025 is to have these services quarterly.
- NEW: Since we weren't able to get to Wapo in the 2023-24 school year, we held a fun and successful 10th Grade "Getting Confirmed" overnight retreat at LOC on March 8-9, 2024 instead.
- **NEW**: Helped with pastoral care while we were in transition between pastors.
- **NEW**: Worked with Tim Johnson to host "Comfort and Calm A Quiet Christmas Gathering" on 12/19/24 for anyone wanting to "slow down" at Christmas, have time for prayer and reflection.



- Had another life-changing HS mission trip in June 2024 with 27 participants+ to Chicago. We raised funds, purchased supplies, and set up 2 refugee apartments through Exodus World Services; served at Bernie's Book Bank, Project CURE, and A Just Harvest; built new relationships and grew in our faith and leadership!
- Monthly Parent Discussion Groups held through last school year led by Pastor Bruce and Kirsten.
- Monthly Summer Youth Activity Nights for grades 7-12 (enhanced with 2 separate gathering times).
- Had a fun day of fellowship and rides with 14 youth and 2 adults at Valleyfair on 7/23/24!
- "Dinner and a Movie" HS Fellowship event on 2/25/24 (made

burrito bowls).

- Prepared and led the VBS opening/closing each day with Katie Kohler (skits, songs, theme, etc.).
- 11 Grad Care Packages assembled by the youth and mailed to the 2024 Grads in November.

• We were finally able to have an "All-Confirmation Retreat" again this fall at Camp Wapo! 42 youth (grades 7-9) and 5 adults attended on Nov. 1-3 and learned more about prayer (see photo).

• Worked with 4 HS youth again to coordinate the *Sleep Out for Homelessness* on November 9-10 to raise awareness and funds for homelessness.

- Continued with monthly Friday Night Lights events - a chance for youth to hang out, have fun, and play games at church!
- Led several "special" Sundays including

 Al Mississ Tria D. town Wasselin
- Camp Sunday, Grad Sunday, and Mission Trip Return Worship.
- Had a successful youth fundraiser on 3/17/24 and raised \$10,785 to help support the youth that went to Chicago and the BWCA in summer 2024!
- 65 Confirmation youth (grades 7-9) during the 2024-2025 school year. We welcome 6 new families this fall!
- Weekly activities for Confirmation youth include SLICE (pizza supper), games, worship & prayers, large group teaching time, small groups, special events, and service events (Feed My Starving Children, Delano Food Shelf, and Love INC, care packages, cards, tie blankets, etc.). Coordinated Confirmation on my own this fall.





- Amazing Guides and Jr. Guides (8 HS youth and 22 adults) that give so much each week for the Confirmation ministry to happen!
- 18 youth affirmed their baptism on 4/7/24 (see photo).
- 19 youth attended Lake Wapogasset Lutheran Bible Camp in Amery,
 WI over various weeks in summer 2024.
- 12 Tie Quilts made and gifted to the 2024 Grads on Grad Sunday (see photo); organized with the help of 2 HS youth.
- Many "administrative" tasks (lots of emails & communication, youth mes-

sages, newsletter articles, curating photos, staff meetings, budget, youth account, recommendation letters, etc.).

- Gave several Children's Messages on Sundays throughout the year.
- Grew deeper through many relational connections... coffee and home visits, attended sporting events and grad parties, sent care packages, cards and messages, phone call check-ins, etc.



Youth and Family Ministry Goals for 2025:

- 1. Work closely with Katie Kohler on the possibility of adding a Wednesday night worship service.
- 2. Assist the new pastor (Tim Wheatley) as he transitions to Light of Christ. Help him get to know the youth and families through ministries where he can quickly become connected.
- 3. Plan and implement quarterly youth worship services to develop youth leadership skills and help all to grow deeper in their faith!
- 4. Add Peer Ministry Training as a part of our summer trips so that youth can develop stronger leadership skills among their peers, in our community, and within our congregation.

Thanks for your love, support, and partnership in 2024. We're excited for another year of growth and adventure while walking with God in our faith!

ENDOWMENT COMMITTEE

Committee members: Brian Harstad, Cheri Ashfeld, Chris Meyers

The Light of Christ Endowment Committee oversees the Light of Christ Endowment Fund that was created in 2019. The committee has three members including Brian Harstad as Chair, Cheri Ashfeld as Secretary, and Chris Meyers, serving staggered terms. The Endowment Fund is an account separate from the church's operating and building capital funds, which is designed to accept and hold both current and future contributions and estate gifts for the purpose of making distributions for ministry.

Due to the favorable investment market results during the past year, the committee was able to again make ministry grants that totaled \$2000 during 2024. Grants were approved and distributed to the church sanctuary prayer rug for \$400, the Chicago youth mission project for \$500, the Estates of Delano resources needs of \$500 and the LOC sanctuary video upgrade fund for \$600. The committee developed new content for the church website to explain the Endowment Fund and provide links to additional information and content from the ELCA. We continue to look for opportunities to educate our church community on legacy giving opportunities and giving options to the Endowment Fund.

The committee monitors the Endowment Fund performance managed through the ELCA. The fund started the year with a balance of \$29,234, and through October, the fund balance has improved through fund earnings and market value gains to a current balance of \$30,663 after the \$2000 grant withdrawal.

HEALING AND WHOLENESS COMMITTEE

The Healing and Wholeness Ministry was created in 2019 in response to our Congregational MAP Survey with the purpose of leading our congregation to be a healing presence for one another and our community. Our goal has been to reflect Christ's love and care through bringing awareness, education, prayer and support to those in our congregation experiencing mental illness, loneliness, grief and brokenness. Our focus has been expanded toward the increasing concern for the mental well-being of youth.

Our ministry accomplishments for this past year include:

- Replaced the "Friendship Pad" with welcome cards, prayer request cards and caring card requests. As a congregation we are becoming more comfortable sharing prayer concerns.
- Held our 4th annual *Walk a Mile in My Shoes* event. Over 100 walkers attended! Collected donations of \$117 for NAMI. Coordinated the event with Children and Youth Ministries and our committee donated pizza dinner for all attendees.
- The O.W.L.S (Older Wiser Lutherans) group has been highly successful! Bible study is held weekly with 15-20 people. A monthly social activity is well attended by 20-25 people. We are growing friendships and genuinely care for one another.
- Caring Cards Through November 5, Cheri Ashfeld has sent out 38 Caring Cards, including Valentine's Day cards to some snow birds! Other requests have been divided between illness and grief. It's so important to reach out in love and concern.
- Monthly Caring Corner articles are written by committee members and shared in the Delano Herald Journal. Topics included: Gratitude, Stress in Teens, Transition as Pastor Bruce was retiring, Disability and Pride month with focus on accepting diversity in God's children, Mental Load on Parents, Compassion Fatigue, Suicide prevention, the importance of friendship for mental health, facing the holidays with addiction and mental fragility.
- We are still operating on a generous 2020 campaign fund allotment and currently do not have a formal line item in the budget.
- Our plan for 2025 is to continue to educate and provide resources and support for those in our church and Delano communities:
 - Plan to start a "Wellness Tool Kit" in January and create a theme for the Caring Corner articles to provide more resources for healing and wellness.
 - Organize a May event (ex: 988 awareness, NAMI QPR or Mental Health First Aid) for LOC and the Delano community.
 - Propose a new welcome brochure to the church council and new pastor (draft ready).
 - Look into "wounded healers" ways we can share our own life struggles to help others.

Our Mission outreach calls us as Christ's disciples to extend compassion and serve those in need in our local and global community. Our Evangelism outreach is to current and potential members to help make LOC a welcoming church home. We also see how important it is to team with our other LOC committees.

Evangelism Activities:

<u>Discover LOC New Partner/Member Sundays</u>: 30 new LOC members were received this year (including baptisms). This committee was involved again as we have in the past welcoming our new LOC partners.

<u>5th Sunday Contributions</u>: Thanks to our generous LOC members for their monetary contributions of **<u>\$17,570</u>** total this year thus far (December is not yet collected and will be added to this number later)

- March: \$1870 Second Harvest
- June: \$700 for Karen Anderson
- **September**: \$15,000 for the Belize van
- <u>December</u>: LOC Birthday Ministries and residents' personal needs at the Delano Estates Nursing Home

Delano Helping Hands Food Shelf Support:

- March Food Share Month: We again did Pack the Pews and collected many items for the Delano food shelf (669 lbs.) as well as throughout the year. Many LOC members also donated individually.
- <u>LOC Member Volunteers</u>: Many LOC members volunteer at the food shelf during our months of March, June, December for families in need. Several LOC members including our LOC kids also volunteer their time throughout the year to help at the food shelf in other ways. JoMarie Williamson, LOC member, is one of the directors of the food shelf.
- <u>Food Rescue</u>: LOC members pick up donated food from Coborn's and Kwik Trip weekly and deliver to the food shelf, Delano Senior Center and other senior apartments in Delano.

Faith Storytelling: Mary Hess did a workshop on faith storytelling for LOC members which was very well received. The committee plans to reach out to other LOC members in 2025 to share her information and offer the opportunity to do more faith sharing.

Nourishing HOPE/Second Harvest Heartland Food Distribution: LOC volunteers have helped each month to box food in Rockford and distribute them at LOC in Delano. The number of boxes of this free food has consistently been 90 each month.





Kids Hope USA

LOC has 12 mentors and 9 prayer partners who are volunteering their services to selected Delano Elementary children. All is working very well with our school district and the children are benefitting from the mentors' compassion.

Gratitude Project:

This committee did a Gratitude Project for Delano Elementary staff for their teaming up on Kids Hope, one for staff at the Delano Estates Nursing Home, one for members of Our Father's Church in Rockford for their work with food distribution, and one for the LOC staff and Call Committee members.

2024 Annual Report

On the evening of Jesus' resurrection, as two of his followers were walking along the road that leads from the city of Jerusalem to the village of Emmaus "talking and discussing, Jesus himself came near and went with them." - Luke 24

Grace and peace to you, beloved of Christ Jesus.

This resurrection story is a favorite. We walk together as church, and Jesus draws near and walks with us. The labors of the day, the content of our discussions, the swirl of society and politics, the hopes and fears, these things shift, and yet, Jesus walks with us and is known once again as we gather together around the table.

What a year this has been. This report to the worshipping communities of the Minneapolis Area Synod is an opportunity to look back on 2024, and to look ahead at the year to come. Most of all, it is an opportunity to name and celebrate some of the ways the Holy Spirit continues to enliven God's church. We give thanks to you and your congregation for your partnership in this ministry we share.

On May 4, 2024, you elected me to serve as your Bishop. On August 1, 2024, I took office, and on September 21, 2024, I was installed during a festive and moving worship service at Central Lutheran Church. This election represents a significant threshold in our synod's life as we continue by the Spirit's leading along paths yet unknown. Thank you for your trust and your continued prayers. We are particularly grateful for the intentional work of the Bishop's Election Committee. My deep thanks to Bishop Ann Svennungsen for her 12 years of faithful leadership, and for her generosity of wisdom and spirit as I learn the ropes. As I have restructured parts of our synod's ministry team, we have had several staff transitions. Some have completed their service, over the summer and fall we welcomed a few new staff, and in 2025 we will welcome more. Thank you to our staff for their patience, perseverance, faithful ministry, and good courage during a long transition.

Stepping into this role, I am more mindful than ever that we are **Church Together**: **Learning Together**, **Listening Together**, **Serving Together**, **Worshipping Together**

A few highlights from 2024:

- 137 worshipping communities, including
 - ♦ 3 new starts congregational
 - ♦ 8 strategic ministries
- 3 congregations marked Holy Closures this year, honoring their years and ministry, and in closing, stewarded their assets by contributing to the Resurrection Fund.
- 11 languages spoken in worship
- 62 call processes in 55 congregations
- · 8 ordinations of new pastors and deacons and
- 24 rostered ministers installed into new positions
- 34 people discerning a call to ministry and active in our candidacy process
- 305 pastors and deacons currently serving in our synod, and around 370 retired ministers
- 52 pastors and deacons serving in specialized ministries, including chaplains, educators, social ministry leaders, and missionaries
- 5 years of Faith Practices and Neighboring Practices cohorts supported by a grant from the Lilly Endowment's Thriving Congregations Initiative, with plans to apply for a scaling grant in 2025
- 17 congregations in the current cohort of Faith Practices and Neighboring Practices, and
- 13 in the first cohort (that's nearly 1/4 of our synod's congregations!)
- \$1.25 million grant received from the Lilly Endowment for Family Faith a project accompanying parents and caretakers from the Synod's new and strategic ministries. Watch for more details coming soon!
- 800 people attended the Bishop Installation in person, including 220 clergy
- \$2,681,409 pledged in Mission Support, with 50% supporting MAS ministry and 50% for ELCA ministry
- 2 companion synod partnerships: Lutheran Church of Christ in Nigeria (LCCN) and the Leipzig District-Evangelical Lutheran Church in Saxony, Germany, including visits from Archbishop Musa Filibus (LCCN), Superintendent Sebastian Feydt and Pastor Cristoph Reichl (Leipzig)
- Synod staff supported leaders and congregations, convening, communicating, collaborating, and navigating conflicts
- Hosted many special events such as an Eco Faith Summit, Boundaries Workshop, Bishop's Theological Conference, Ministeriums, and Communicators Gatherings

What a gift to reflect on the amazing ways we were Church Together in 2024! We look forward to 2025 with the Conference Assemblies in February, Synod Assembly (May 2 - 3), and the ELCA Churchwide Assembly (July 28 - August 2). We walk together as church, trusting that Jesus continues to come near and walk with us. We are Church Together.
