- Income exceeded expenses despite being lower than 2020 budget
- Committees and staff did an excellent job controlling expenses
- Actuals do not include the Paycheck Protection funds granted

2021 Business

- Adopt 2021 Budget
 - Anticipate lower faith sharing in first half with annual levels 'flat' to 2020
 - Includes a staff increase of 3%
 - If your committee has an incremental financial need, please bring forward to the Council. We are here to support growth opportunities and committed to helping fulfill these opportunities.
 - Any request under \$5K can be approved by Council, anything over needs congregation approval
 - Motion Approved: 1st Wes Aylsworth; 2nd Van Donahue
- Adopt Funds for Technological and Capital Improvements in 2021
 - Technology and building improvement needs have been identified including:
 - Window and steeple maintenance needs

- Screen and technology updates in sanctuary and Sunday School classrooms
- Addition of \$10,000 to youth room remodeling
- The council proposes allotting \$60,000 from the reserves in our general fund to cover these improvement and repairs:
 - The church mortgage will be paid by end of 2021 and our reserves are healthy
 - The budget should be used to cover normal, ongoing expenses, but is not designed to cover larger improvements
 - Completion of these updates prior to return to worship will be less disruptive
 - Investing in our church is important to drive growth and build for our future

- Columbarium Update
 - Light of Christ's Columbarium/Memorial Garden area will consist of a beautifully landscaped area, adjacent to the church sanctuary. It will provide a peaceful place for prayer and meditation.
 - Status of project
 - Bi-laws have been created
 - Columbarium supplier determined Eikhoff Columbarium, based in Crookston, MN
 - Final stages of determining columbarium size/style
 - Memorial Garden/Columbarium site determined
 - Preliminary landscape design determined
 - Project timeline determined
 - Next steps:
 - Budget to be finalized
 - Congregational approval. Educational meeting and vote date, more info to come.
 - Financing to be secured
 - Project completion goal date with congregational approval, November 1, 2021
- Endowment Grant Award
 - The Light of Christ Endowment Fund is:
 - A separate account from the church's operating and building funds
 - Accepts & holds current and future contributions and estate gifts
 - For the purpose of making distributions to fund ministry
 - Committee members are Brian Harstad, Amy Bigot and Jonathan Ness
 - Fund balance as of Dec 31, 2020 = \$29,741
 - Initial church contribution from June 2019 = \$25,000
 - Plus fund returns of \$1,479 and market value increase of \$3,262
 - Goal: begin using a portion of the fund's income to make grants to fund ministry in the church & community in early 2021
 - Now seeking grant applications for ministry needs from church members
 - Programs or needs within church or community for grants of \$100-\$500 or more
 - Contact church office or committee member for application form
 - Accepting applications during February
 - Future Legacy Giving education sessions to be planned
