 Personnel Committee joining at 7pm- Paid Family Leave policy Beth 	
Coulombe joined the committee to share the new MN paid leave policy that provides job protection and pay for qualified work "leaves" (as defined in the policy). The employer and employee share the cost of the premium rate	
(.66% for small employers). Need to determine what portion will be covered by LOC vs by employees within the parameters of the program beginning in	
2026 and who will administer this program when benefits are initiated (and be privy to private information)? We need these answers by 12/1/25. Beth recommends a person with an HR background as the primary administrator	
and council member(s) as a backup. The personnel committee will be training employees and preparing communications. Laurie will research	
whether HR firms are likely to provide this service. A 2-3 year term for the HR representative would make sense (Pastor will contact the personnel	
committee to pursue options), one of the council member and Pastor as part of the administration team would make.
