Special Congregational Meeting Minutes April 22, 2018 – 9:30 AM

Meeting called to order at 9:32 AM

Background – A few years ago we partnered with Kairos to do the Holy Cow survey during our transition. Now that we have new staff and new members we are at a different place and are looking for someone to help us navigate the future.

Tim Johnson, Kairos – Snapshot of different organizations affiliated with Kairos and what they would be doing for us. Organizing and planning, congregational survey, external listening and discovering (leaders and community members from outside the church), a leadership systems inventory, stewardship ministry assessment, analysis of communication tools, preparing and planning (formulate smaller teams), inspiring and implementing (plan roll out).

Questions:

How did we get results? Vital signs report used by the call committee, council, new staff members.

If debt reduction is part of the plan, why wouldn't we use the \$24,500 to pay towards the reduction? Churches and organizations who use this process raise more money than organizations who don't.

Is how to develop growth in the congregation part of this? Stewardship and greater clarity of purpose are tied together. Raising peoples' energy level and excitement is part of this. Growth is a part of that.

Will Kairos help us learn to slow down and really listen to what God is asking us to do? Yes, this is fundamental to what Kairos is doing. The spiritual listening group will be put together to make sure that what we are planning and doing what God is wanting us to do.

Will this help us develop a way for us to use peoples time, talent, and treasures and could people in the congregation be doing some of this process? This process is dependent on the congregation engaging in this process and using its own resources.

Is the council unanimous in their recommendation? Yes

Where is the money coming from? We have \$110,000 in a mission investment fund that has been sitting in a savings account for years. We would use a portion of this to pay Kairos. We would plan to replace the fees with the money we raise.

Transparency with council – All council meetings are open to the congregation. The council meets the 3rd Tuesday of each month at 6:30 pm. Agendas and minutes are posted in the narthex.

LOC has a great track record of raising funds in order to support our mission. We have done this more than once in the past. The sanctuary and education wings were both products of these

Have we spoken with other congregations who have gone this process? We have not surveyed other congregations, we are relying on our history. We did check with other firms. The pricing structure is about double the price for half the help.

How much involvement will we need from the congregation? Significant involvement. The goal is to have a lot of people involved. This is essential in order to build energy. When the project is organized it is easier to get involvement because people don't feel like they are wasting their time.

Are there statistics to estimate our success? There are so many factors that isn't really possible. Ultimately, this will be dependent on our engagement to the process.

How do we make sure we are getting what we paid for? There are checkpoints in the process. The first portion is happening quickly and there isn't a need for follow up but for years 2-3 there are quarterly check ins built in.

Six years ago LOC did a \$180,000 capital campaign was done in house. It was a full-time position for multiple people and that had nothing to do with visioning.

Motion to approve an expenditure of \$24,500 to enter into a partnership agreement with Kairos and Associates for consultation services relating to the development LOC's strategic vision and facilitation of a likely capital appeal.

Dear sisters and brothers,

We are God's beloved children, living in God's beloved community, and caring for God's beloved creation. That is who we are, and that is what we have been saved and sent to do. We are called to live the good news of transformation—God's and our own. We believe that the Son of God became like us in every way, except sin, so that he might make us like he is now. The Holy Spirit is at work in the world to make us new creatures who will one day be able to love as Jesus loves; and we live this out in Christ's new, beloved community in which everyone is welcomed, cherished, and loved; and we care for God's new creation in which all creatures and all creation will be at peace. We have been called by the Holy Spirit to be a part of this divine work of transformation.

2018 was another good year here at Light of Christ. We have much to celebrate. Here are some of the highlights of the year.

1) A stronger worship and music ministry

Strengthening our Worship and Music Ministry. Over the summer we established a Music Director Search Committee. The committee members are Laurie Brown, Michelle Bunker, Sue Fink, Bridget Hanson, Marcus Hanson, JoMarie Williamson, and me. In the course of our work we came to the conclusion that Light of Christ will be best served by moving from a part-time music director to a full-time worship and music director. The Council approved this recommendation and this increase in staffing is reflected in the budget for 2019. We believe that a full-time worship and music director is an essential investment in our worship life and in the future of our congregation.

Sermons, Sacraments, Services, and Rites. Over the course of the year I prepared and presided over 90 worship services, 1 funeral, and 17 baptisms. I preached 47 different sermons, and gave 20 fourth graders their First Communion.

2) A more vital youth and family ministry

In August we bid farewell to Rachel Bash, our beloved Children, Youth, and Family Director as she left us to pursue a Master's degree in Environmental Studies at Duke University. We miss Rachel and yet pray all the best for her as she prepares for this new calling to which the Lord has led her.

We established a Youth Director Search Committee to find a successor to Rachel. The Committee was comprised of Annette McClelland (chair), Rachel Bash, Amber Becker, Shannon Durick, Gwen Egly, Erin Green, Ryan Green, Laura Jaunich, Dan Langner, Vicki Noetzelmann, and me. Thanks to each of them for all the hard work on this search.

Our work was rewarded in August when we were blessed to bring onto our staff two new staff members: Kirsten Kelly, who is our part-time Children, Youth, and Family Director; and David Schneck, our full-time Associate Children Youth, and Family Director. Both are off to a good start and we are delighted that they are leading our Children, Youth, and Family ministry.

3) Growing in Generosity in Time, Talent, and Treasure

A New Day for God's Beloved. In May we held a special congregational meeting at which we decided to hire Kairos and Associates to lead us in a strategic planning process. Tim Johnson is the consultant from Kairos who is leading us in this process. We are blessed to have Tim lead us for many reasons, one of which is that he and his family are members here at Light of Christ. As a part of that process we explored the feasibility of a major capital campaign.

In November, at a second special meeting, we decided to move forward with a major, three-year capital campaign in 2019. Our first priority is to retire our indebtedness of around \$435,000. Our second priority is to address about \$500,000 in capital repairs and improvements that we'd like to take care of in the next five years.

We have also started to develop a three-track, long-range financial model for Light of Christ. **The first track is growing our regular, annual giving**. This track will fund our on-going, annual mission and ministry – staffing, mission and ministry, and regular building upkeep.

The second track is periodic capital campaigns. I believe it will be best for us to conduct a capital campaign every five years or so. These capital campaigns would be designed to meet the major, occasional building and grounds needs of the congregation, for example, replacing a roof, or a furnace, or expanding a part of the building, or expanding and improving the parking lot. This is a sensible, cost-effective way for us to take care of our capital improvement needs.

The third track is our Endowment Fund. We established an Endowment Fund Task Force. The members on the task force were Amy Bigot, Brian Harstad, Jonathan Ness, and me. We composed by-laws for an Endowment Fund which will be brought to the congregation at our Annual Meeting for approval. The Council agreed to take \$25,000 from our Mission Investment Fund account and use that to start our Endowment Fund. The Endowment Fund is a financial instrument in which the principal is invested by the Endowment Committee and then only the interest from the principal is spent on mission and ministry. The principal is left untouched and it grows primarily through special gifts or bequests from estates.

This spring, Erin Johnson resigned as our church treasurer after serving so capably the previous three years. Thanks, Erin, for all your work! We conducted a search process led by our Personnel Committee. From that process **we hired Debbie Johnson as our new part-time financial administrator.** Welcome, Debbie!

4) Becoming a more welcoming community

Loving relationships are at the heart of our life together as a congregation.

New Members. We held three Discover Light of Christ sessions in 2018. These sessions are designed for those interested in becoming members of Light of Christ and also those who are interested in learning more about our congregation. We received 20 families as new members for a total 67 new members. Welcome to our family of faith!

New Website. In the fall of 2017 we formed a Website Task Force to work on a new website. My thanks to the task force members: Cheri Ashfeld (chair), Rachel Bash, Billie Chock, Ryan Green, Paul Ludwig, Brad Pappas, and me. We hired Five Technology here in Delano to design the new site. We launched the site in August and we will continue to improve and refine it in the months to make it more useful to those both inside and outside the congregation.

All in all, it has been a good year. I'm so thankful for your partnership in the Gospel here at Light of Christ. I look forward to what the Holy Spirit has in store for us in the years ahead as we seek to become more and more like Christ.

2018 ANNUAL REPORT FOR CHILDREN & FAMILY MINISTRY (Preschool – Grade 6) Kirsten Kelly, Director of Children, Youth & Family (in consultation with the Children & Family Ministry Team)

It is difficult to complete an accurate annual report for a congregation that you haven't worked at for an entire year; however, what I can provide is a fresh perspective on the ministries that are taking place at Light of Christ. After just 4 months, it is clear to me that the families and Light of Christ congregation truly WANT to be involved and engaged in the lives of its children and youth. This is exciting and refreshing since this is not always the case at every church! The number of volunteers that participate, the amount of people that serve in leadership roles and the willingness of adults to volunteer, have all demonstrated this fact to me in the short time I've been on staff at Light of Christ. It is clear that families are invested in the ministry and committed to its success!

It is also encouraging to see so many children involved in the ministries at Light of Christ. Here is a quick snapshot of the main children's ministries at Light of Christ:

- Approximately 20 kids attended the 5th/6th grade retreat in January and went to Northern Star Base Camp for the afternoon.
- 9 children (grades 1-4) attended Half Blast Bible Camp through Green Lake Lutheran Ministries.
- 4 middle school youth went to Camp House in July (a partner camp of Green Lake Bible Camp).
- Summer Stretch took place again in the summer months for completed grades 4-8.
- 78 children (preschool 4th grade) attended Vacation Bible School in August; 25 adults and 31 youth (grades 5-12) volunteered to make it a success!
- Fall 2018 began the 2nd year of Spark (Wednesday after school ministry for grades 2-6).
- 169 children currently registered for Sunday School (2018-19 school year).
- Several special events during Sunday School 150 Operation Christmas Child shoeboxes filled and sent to children in need, 20 fleece tie blankets made for Camp Noah, flower pots decorated for nursing homes and wind chimes made for mothers.
- Children sang in worship several times throughout the year.
- Bible Camp Stock Fundraiser took place in April and raised nearly \$1000 for the scholarship fund.
- Staff led many children's messages in worship including the Blessing of the Backpacks on Rally Sunday.
- 35 children participated in the cast of the Christmas Program, which took place at both services. All Sunday School children were encouraged to participate in the chorus. It was a wonderful program and the kids did awesome!
- Monthly Children & Family Ministry Team meetings (formerly the Christian Education Committee). This group is the backbone of the ministry and includes the key volunteers that make decisions and then helps to make sure ministries get carried out and go smoothly. This is a group of rock stars and we are so blessed to have them!

Current members of the Children & Family Ministry Team: Amber Becker, Jen Burbach, Shannon Durick, April Fritz, Melissa Hillmyer, Laura Jaunich, Susie Larison, Tara Olson, Andrea Quandt (council rep), Kim Wortz & Kirsten Kelly (staff).

Some goals that I have set for myself and the children and family ministry for 2019:

- 1. Increased participation in summer Bible Camp. I will be working hard to encourage children to attend Lake Wapogasset Lutheran Bible Camp this summer with Light of Christ kids and staff, since camp is transformative to the ministry that takes place at church the rest of the year!
- 2. Have fall 2019 info and registration ready by spring so registration can take place before summer.
- 3. Increase parent involvement in Spark (Wednesday after-school ministry).
- 4. Begin conversations about possibly increasing the after-school ministry options on Wednesdays. The hope is to include the new Music Minister in these conversations since one important aspect of this would be children's music groups.

My family has been blessed by our participation at Light of Christ and we look forward to getting to know everyone better. I just wish I could know everyone's names already... I'm so anxious to be able to call everyone by name! Yet I know this will take time, especially since I'm only working part-time. Thanks for your patience as I get to know you and your families! I truly look forward to partnering together in the ministries at Light of Christ and I encourage everyone to find a way to participate so I can get to know you better in 2019!

ASSOCIATE DIRECTOR OF CHILDREN, YOUTH & FAMILY MINISTRIES David Schneck

Thank you. First and foremost, thank you for welcoming me into your congregation this September. These first few months have been an exciting whirlwind of meeting new people, getting familiar with different programs at Light of Christ, and determining how I can best apply my talents to help the ministries at this church. Transitions of any kind are difficult, but I can say without a doubt that the congregation has done an exceptional job of welcoming a young, energetic kid into a full-time position on its staff. So, thank you once again.

As Associate Director of CYF ministries, I have been mostly working with youth from grades 7-12, but I have had the chance to learn and play alongside some of the Pre K - 6th Grade students as well through our Sunday School and SPARK after school programs! In particular I have the joy of leading music and games for some of these younger children, which is an absolute blessing. One of my main focuses here at LOC is Confirmation, which has been an amazing time for me to connect with the 7th - 9th grade youth in the congregation. This is an opportunity for me to get to know both parents and students better at congregation members' homes! Alongside this, we are having regular High School Fellowship on Sunday mornings between services instead of Wednesday nights. All of these initiatives are in efforts to continue building relationships with students in environments they feel comfortable and can be themselves.

When people ask why I chose to accept this position, I say it's simple: I chose to accept a position as a youth director because I love walking alongside youth in their faith lives and seeing them learn and grow spiritually. Through my time working at camp, I discovered that one of the best ways to guide youth in their walks in faith is through a relational ministry: building relationships is essential in faith forming. SHARED MINISTRY ANNUAL REPORT Jinnelle Weis, Shared Ministry Coordinator

Light of Christ has a strong history as a faith body committed to **Shared Leadership.** Participation from everyone is encouraged. Only with Shared Leadership can Light of Christ reach its maximum potential as a church body. And, with participation our volunteers benefit in creating new relationships, enjoy new friendships, create new support systems and strengthen faith.

Every one of us is blessed with God given talents and gifts. They may all be different, but they are all valuable and are all meant to be shared. **And, share you did in 2018!** Light of Christ had over 100 members sharing their gifts through participation in church council and committees. We had approximately 31 persons contributing as worship assistants every Sunday morning. One of the greatest blessings of assisting in worship is the ability to do so as a family – involving youth in worship services is a strong part of our belief that children are an important part of worship at Light of Christ.

With support of volunteers, 2018 brought hospitality/fellowship opportunities between worship services utilizing our Monthly Service Teams. An experienced usher mentor group is now available to assist persons wanting to serve in this capacity on Sunday mornings. 2018 was a year of transitions in the church with the hiring of two new directors of Children, Youth, and Family Ministry. We are continuing to engage and energize our youth programs at Light of Christ with a variety of programs.

Confirmation

The goal of sessions on Wednesday nights are to provide the youth with the necessary faith practices to grow in their individual faith lives. As a church, we transitioned away from a lecture-based teaching style into more discussion this past year, and we've heard plenty of positive feedback from this change. Each evening after content is finished, students can choose to either sing in the "New Directions Choir" or participate in a small Service-Learning project. Both of these activities provide a fun way in which to express their faith: in song or in service. It's been wonderful to see all the work the students are putting into these two activities.

High School Mission Trip

This past summer, Light of Christ took 25 students and 5 volunteers all the way down to Atlanta, GA to serve with an organization call *Serve Boldly*. This organization emphasizes the importance of meeting the specific needs of the community in which they serve. Alongside their service, the youth were able to learn about our nation's history, Martin Luther King Jr's legacy, and how the Civil War affected Atlanta. A total of 7 freshman, 5 sophomores, 6 juniors, and 7 seniors attended this week-long trip. As preparation for the trip, students have to earn 10 "Service Points" by participating in local service projects or sharing their talents in church. This is in effort to emphasize the importance of a lifelong commitment to service.

High School Fellowship

On Wednesday nights, 9th - 12th grade students gather in the youth room for "HSF." This is a time and space for students to come have fun, take a break from their busy schedules, and enjoy each other's company. Starting in January, HSF will be on Sunday mornings between Services.

Here is a detailed look at all the ways in which we engaged our youth at Light of Christ this year.

Bishop Svennungsen's Annual Report

Your congregation matters! It matters because the *gospel* matters. The Good News of Jesus Christ proclaims that, in God's eyes, you are enough. The world is great at telling us we're not enough. "Do more. Be better." But God's *grace in Jesus Christ* says something else. Not only are you enough, you *belong*; you are welcome into beloved community. In that community, God provides food for the journey, friends in faith, and power to live out the presence of Christ in our daily lives.

The church matters because of the *gospel*, because of the *community* it forms, and also because the *world* needs the church's *voice*. Our communities need us to speak of God's love for all people, no exception; to advocate for the care of creation; and to build cities and neighborhoods where justice is the standard for all our work.

The church matters. Everything we do in the synod office is poured into this conviction.

Because the church matters, congregations matter:

In 2018, the synod walked with 58 congregations in call processes and assisted 52 congregations in work such as stewardship growth, conflict resolution, vision discernment, and anniversaries. Through the new Resurrection Fund Imagination Grants, we made legacy awards totaling \$270,230 to 40 congregations and ministries to further the mission of the gospel. And, in addition to our 145 congregations, the synod has five new mission starts: Tapestry, Intertwine, Tree of Life, Amazing Grace, Southwest Latino Ministry.

Because the church matters, leaders matter:

With nearly 700 rostered leaders, our synod has 313 in active calls, 31 on leave, and 347 retired. We work hard so the church receives the mature, faithful and theologically well-formed ministers it needs. In the years ahead, we will focus even more on raising the next generation of gifted and diverse leaders who will carry a message of God's love to a multiracial world.

Our Tool Kit gathering is a favorite for elected congregational leaders, and we invite you to consider bringing your church council to the 2019 Tool Kit at St. Stephen's Lutheran Church, Bloomington, on Saturday, February 23, 2019.

In 2018, we supported 69 persons in the candidacy process as they prepare to become deacons or pastors. We ordained 11 pastors and installed 25; we had a combined attendance of 463 pastors and deacons at our Ministeriums, Bishop's Theological Conference, and the Lunch and Learn gatherings; and we have 250 leaders meeting in peer groups. We also gave scholarships to 38 pastors to attend a conference on supervision and building healthy teams.

Because God's world matters, the church's voice matters.

Together, the congregations of the synod are working to foster racial, environmental, and economic justice. With grants from InFaith Community Foundation, the Bush Foundation, area Watershed Districts, and local congregations, we have called three synod staff members to lead congregations in this work. We also trained 65 leaders in faith-based community organizing.

It is the generosity of congregations like yours that make the synod's work possible. Thank you! We seek to be careful stewards of every gift. For the fifth straight year, we've been given a clean audit. For our fiscal stewardship as well as for the synod's excellent governance, I give thanks to our synod council and to Vice President Felicia Boone. Our synod is also blessed with an extraordinary staff who work with humility, tenacious commitment, wisdom, creativity, and hope. We also rejoice in the two full-time Lutheran Volunteer Corps Members on our staff and the age and ethnic diversity our growing staff brings.

I conclude this annual report with a word of deep gratitude for the privilege of serving as your bishop. Especially, I thank you for calling me to serve a second six-year term. I praise God for our shared mission and our vital partnership. Please let us know how we can serve one another better—working together so all experience gracious invitation into life-giving Christian community and live in just and healthy neighborhoods.

Light of Christ Lutheran Church Endowment Fund Bylaws

3976 County Line Rd. SE, Delano, MN February 27, 2018

Purpose

An Endowment Fund ("the Fund") is an account that can hold funds from both current and estate gifts, from which distributions are made for ministry. This document describes how Light of Christ defines ministry and outlines the overall management of the Fund. Ideally, the principal of the Fund grows over time, primarily from additional gifts, but also from investment returns, as distributions are made from the earnings of the fund.

Operation

- 1. Endowment Committee
- 2. Investment Policy
- 3. Distribution Policy

Endowment Committee ("the Committee")

- 1. The Committee will be comprised of 3 members. When the endowment fund reaches \$100,000, the committee shall be increased to a total of 5 members.
- 2. Members of the Committee will each serve for 3 years. Initially, members will serve staggered terms of:
 - a. 1 member for 1 year
 - b. 1 member for 2 years
 - c. 1 member for 3 years
 - d. After the first year, each new member will serve a 3-year term.
- 3. No member may serve more than 2 continuous terms of 3 years.
- 4. After a lapse of 3 years, a former committee member may be re-elected.
- 5. Any member of the congregation, the Pastor, the Church Council, the Stewardship Committee, the Endowment Committee, or the Nominating Committee may nominate a candidate for the Committee.
- 6. The Committee members will be elected during the Annual Congregational Meeting by the members of the Congregation.
- 7. If there is a vacancy on the Committee, Church Council can appoint someone until the next scheduled election.
- 8. The Committee will meet at least semi-annually, or as needed.
- 9. A quorum shall consist of at least 3 members and can carry any motion or resolution with a unanimous vote of at least 3 members present.
- 10. The Committee will elect from its membership a chairperson, secretary, and treasurer.
- 11. The Committee will report to the Church Council at least annually, or as requested.

- 12. The financial records of the Fund must be audited at least annually, by a congregation member nominated by the Finance Committee.
- 13. Members of the Committee will not be held liable for any investment losses but will be held liable for his or her own willful misconduct.
- 14. Members of the Committee will not be able to engage in transactions of the Fund in which he or she has a direct or indirect financial interest.

Investment Policy

- 15. We *plan* on withdrawing the principal in the event of emergencies only.
- 16. The Fund can be held in the ELCA Endowment Fund Pooled Trust Fund A, the ELCA Mission Investment Fund, a state bank, or a federal bank. foundation.

Distribution Policy

- 17. The Committee is limited to an annual distribution of 4% of the Fund balance, defined by the account balance as of December 31 of the previous year, which includes all interest, dividends, realized/unrealized capital gains from the previous year.
- 18. Any requests outside the Committee must be made by completing a grant application (Exhibit A), following the guidelines outlined on the application.
- 19. The Committee is limited to the following portions of each annual distribution, unless approved by Church Council, or a congregational vote:
 - a. No more than 50% can be used for our congregation
 - b. No more than 25% can be used for our synod
 - c. No more than 25% can be used for ELCA Churchwide ministries
 - d. No more than 25% can be used for ELCA-related ministries
 - e. No more than 25% can be used for all other non-Lutheran charities
- 20. In the event our congregation ceases to exist either through merger or dissolution, disposition or transfer of the Fund shall be at the discretion of the Church Council in conformity with the Congregation Constitution and Bylaws, and in consultation with the Bishop of our synod of the Evangelical Lutheran Church in America to which this congregation belongs.
